Village grass cutting 2012 . Two quotations in the region of £1000 based on 12 cuts of the wide verge west of the Old Vicarage and 4 cuts of verges in Kimbolton Road which are not part of domestic or farm frontages were presented to the meeting. Following discussion it was resolved to seek a quotation from the County Council contractor to cut the village verges at the same time as he cuts the outlying verges (3 times per year). As 12 cuts was considered excessive for the wide verge, the Clerk will ascertain how many Mr. Royles has been doing.

Budget and precept for 2012/13 . It was resolved to set the budget as appended to these minutes and to set the precept at £3300.00 (the first increase for 7 years)
